#### Friday, April 28, 2023

- 03-01. Call to order Moderator TE Jim Braswell called the meeting to order at 1:00 pm and opened with prayer specifically for Moderator Don Kirkey who is absent because of physical suffering providentially hindering him from attending and moderating the meeting.
- 03-02. TE Brian Land was recognized to thank the area churches who helped in putting the meeting together. Professor Stefan Gerbino of Reformed Theological Seminary was invited to welcome the presbytery to RTS and introduced a welcoming message from President Mike Kruger.
- 03-03. TE Nate Wolcott led the presbytery in opening prayer & worship.

03-04. TE Brian Martin gave part one of the Missions Team Report on the global mission through the missionary work of World Outreach Missionaries Elias and Caris Yohannes who will be going to work at the Bingham School in Ethiopia. They have received the full financial support needed to move onto the field. They are making last minute preparations to leave in ten days. A presentation by video was shown enumerating the need of prayer for humility and dependence on God for the coming year. Cyndie Howard, a member of a Home Team, gave a report from the home team for Asaph and Lynn Dinn's work in Pakistan that began in 1995 and partnered with EPC in 2012. The Clark Abon Center proposal has been approved by World Outreach and the Dinns are looking to raise \$ for next twelve months to purchase land and erect a building to use of the ministry. Home Team summer will gather with Asaph and Lynn on August 1-2, 2023. PRMI will host the event.

03-05. Preliminary Matters – Moderator RE Don Kirkey asked Stated Clerk TE Robert Howard of the meeting's attendance and the Stated Clerk declared there is a quorum though the parity of two Ruling Elders to each Teaching Elder was not met. The Stated Clerk will work to improve the parity issue in future meetings. The Moderator entertained a motion to adopt the docket. The motion was seconded and unanimously approved by voice vote. The Stated Clerk reported on a communication from the Stated Clerk of the Presbytery of the Southeast asking that the Presbytery of Central Carolinas rescind its vote from the previous January 27-28, 2023, meeting that overtured the EPC General Assembly to grant a change in the boundary between the two presbyteries so that two churches might move their membership in to the PCC. A motion to rescind was made and seconded. After some discussion and news that the General Assembly's Permanent Judicial Commission ruld the overture was out of order, the Moderator entertained a substitute motion to table the request. Motion to table was seconded and approved by voice vote.

032-06 The Moderator invited Mr. Tyrel Huntley, staff member of Lake Forest Church, who has been hired to help in the formation of a satellite campus to plant a mission called UCity. The launched of this ministry began at the end of COVID. It is an endeavor to be a multi-racial mission group serving the northeast university area of Mecklenburg County in NC. Mr. Huntley gave a progress report on that work.

03-07 The Moderator called on the Stated Clerk TE Robert Howard to give a report. The Executive Council met on March 11, 2023 at Overbrook Presbyterian Church, Gaffney, SC, and approved the following:

- That the Church Health Coordinator be appointed as an ex-official member of Executive Council with voice and not vote. Motion was seconded and approved unanimously.
- Approved support of TE Brian Land, Missional Director, to have time off to enjoy a sabbatical in the months of June, July and August of 2023 and to retain him as the Missional Director during this time.
- To invite Rev. Kyle Sims of the Associate Reformed Presbyterian Church, or a fellow member of Rev. Sims choosing, to attend the 3<sup>rd</sup> Stated Meeting of the Presbytery of Central Carolinas on April 28<sup>th</sup> 29th.
- To invite TE Bonnie Gatchell and Director of Route One Ministry to address the September 2023 meeting as the primary speaker.
- The Executive Council discussed the future places to meet and the dates for those meetings to be as follows:

Concerning the long-term planning of the Presbytery, the Executive Council recommends the following motions to clarity the roles and responsibilities given to committees of the Presbytery.

- Motion: To approve the Minutes from 2<sup>nd</sup> Meeting of the 2<sup>nd</sup> Stated Meeting of the Presbytery of Central Carolinas on January 27-28, 2023.
- Motion: The Executive Council recommends to the PCC that the bylaws be clarified by
  assigning oversight responsibility for all non-localized worshiping communities (i.e., mission
  groups and mission churches) to the Church Planting Committee. The motion was seconded. The
  motion was approved unanimously.
- Motion: The Executive Council recommends to the PCC that the bylaws be clarified by assigning oversight responsibility of those localized churches within the presbytery seeking to be equip for revitalization and evangelism to the Church Development Committee. The motion was seconded. The motion was approved unanimously.
- Motion: The Executive Council recommends to the PCC that its bylaws by clarified that
  localized churches in crisis or dissolution are under the responsibility of the Ministerial
  Committee and that Transitional Pastors are under the responsibility of the Ministerial
  Committee. The motion was seconded. The motion passed unanimously.
- Motion: The Executive Council recommends approval of a motion to endorse seminaries that are approved by the Endorsement Committee (a sub-committee of the Executive Council) and meet the following criteria:
  - 1. The seminary fully endorses the EPC's "Seven Essentials of the Faith."
  - 2. The seminary offers coursework that meets EPC ordination educational requirements as outlined by the General Assembly's *Procedure Manual for Ministerial and Candidates Committees* (see page 40 under "Candidate's Educational Equivalency Program").
  - 3. The seminary is accredited by the Association of Theological Schools (ATS), thus meeting their accreditation requirements.
    - Endorsement Process: For an institution to be added to the endorsement list, the president of the seminary must submit a request to the stated clerk of the PCC demonstrating the required criteria specified above. The stated clerk will send the request to the Endorsement Committee, which will review the application and confirm eligibility. Upon recommendation from the Endorsement Committee, the request will be sent to the Executive Committee of the presbytery to submit a motion to the presbytery for final approval, at which point the institution will be added to the endorsement list designated below. Institutions must renew their endorsement every year with the stated clerk prior to the September presbytery. The motion was seconded. The motion passed unanimously.
- Motion: To re-establish a relationship between The Evangelical Presbyterian Church and The Associate Reformed Presbyterian Church, at the Presbytery level and invite Rev. Kyle Sims, a member of the Associate Reformed Presbyterian Church to address the court. The motion was

seconded. The motion passed unanimously. Rev. Kyle Sims brought greetings and encouragement in this step developing a fraternal relationship.

03-08. The Moderator recognized PCC's invited guest speaker, Rev. Dr. Paul Borden who addressed with the court the topic of "Growing Healthy Churches". Dr Bordon Executive is the Director of Wooddale Advance (<a href="www.wooddale.org">www.wooddale.org</a>) and has written extensively on the topic of Congregational Transformation. The address covered the issues of needing hope in light of the current setting of Protestant Christianity and the decline that has been evident in the USA. Dr. Borden attributes this decline to churches no longer being on mission of the Church of Jesus Christ. Though there is reason for despair, there is also reason for hope by returning to the essentials of discipleship through improving leadership development. This development can be done through the influence of the Presbytery's work and the congregation's willingness to reorient itself toward a missional model of ministry.

- 03-09. At the conclusion of Dr Boden's presentation the Moderator called the court into a recess for a time of Fellowship and Dinner reminding the court of the evening worship service scheduled for 7:00 PM. The Moderator adjourned the court with prayer.
- 03-10. The court gathered at 7:00 PM to worship the Lord. The worship included music, an address by TE Dr. Don Fortson from the Scriptures and a time to celebrate the Lord's Supper

#### Saturday, April 29, 2023

- 03-11. The Moderator, TE Jim Braswell, called the meeting back to order at 9:00 am.
- 03-12. The Moderator recognized Rev. Kyle Sims, a member of the Associate Reformed Presbyterian Church and invited him to bring greetings and encouraged the PCC in the step it has taken to develop a fraternal relationship with the Associate Reformed Presbyterian Church.
- 03-13. TE Brian Land, Missional Director, was recognized by the Moderator to bring the court a report on the need to help our congregations reevaluate their need of relational and missional ministry. The metrics of a healthy church involved good fruit of prayer, bible study, etc. One metric is heart health and spiritual vitality of the Ruling Elders. He encourage the Teaching Elders and Ruling Elders to risk the hard choice of being creative and purposeful in being involved in church planting and begin that work in using cohorts as a way of building relationships with each other that would encourage missional efforts of groups of congregations.
- 03-14. The Moderator invited a report from Church Development Committee delivered by TE David Taylor. TE David Taylor reminded the Presbytery of the role and purpose of church health and the importance the EPC General Assembly has placed upon this issue by funding for three years in every Presbytery a Church Health Coordinator. TE David Taylor introduced TE Rob McClelland by way of video. TE Rob McClelland laid out the vision of building a Church Health Cohort and invited anyone interested in this endeavor to contact him and consider becoming a Church health coach as a resource for the Presbytery.
- 03-15. The Moderator invited Mike Moses to give an update on Lake Forest Church plants that congregation has worked to support.
- 03-16. RE Dan Barry gave an updated report from the Stewardship Committee on how the Presbytery is doing in funding the EPC's work as a denomination and the PCC as a Presbytery. The receipts

are not keeping pace with the budget expectations. Congregations were encouraged to not wait until the end of the year to send in their contributions.

- 03-17. The Moderator invited TE Anthony Rodriguez to give a report from Church Planting Committee. The newly formed committee would like to cast a vision of every congregation being involved in some manner with supporting the Presbytery's efforts in planting new churches. Each church was encouraged to be involved by being involved in at least one of three ways: planting a mission group, partnering with a mission group being started and/or committing to praying for a mission or the opportunity for a mission to begin in an area of the Presbytery. TE Anthony Rodriguez also gave an update on the formation of the Hampton Project by-laws being written under the leadership of RE Elizabeth Gibson of the Presbytery of Coastal Mid-Atlantic.
- 03-18. TE Brian Martin was invited by the Moderator to give the second part of the Missions Committee report to the court. The court was reminded of the resources that the EPC and the PCC has made available for mental health of missionaries and pastors. Anyone needing assistance should be in touch with Presbytery for assistance.
- 03-19. The Moderator TE Jim Braswell recognized TE Nate Atwood who wished to reconsider the Ascending Overture to the 43<sup>rd</sup> General Assembly approve at the January 27-28, 2023, meeting of the PCC:

Approved Overture: We, therefore, as the Presbytery of Central Carolinas and the Presbytery of the Southeast, overture the 43<sup>rd</sup> General Assembly to realign the boundaries of the Presbyteries of the Southeast and Central Carolinas to move these two churches: Plumtree Presbyterian Church, Plumtree, North Carolina and Providence Presbyterian Church, Clyde, North Carolina formerly in the Presbytery of the Southeast into the Presbytery of Central Carolinas.

The motion to reconsider was seconded from the floor. After discussion on the progress of the overture being ruled unconstitutional by the General Assembly's Permanent Judicial Committee and the decision of the Presbytery of Southeast to rescind the joint overture, the motion to reconsider was unanimously approved by voice vote.

03-20. TE Nate Atwood offered a second motion:

Motion: That the overture be redirected to the Executive Council to improve or recraft an overture with other parties (i.e., GA staff, neighboring presbyteries, etc) that will resolve the issue of the boundaries of the respective presbyteries and bring to bring such overture to a future presbytery meeting of the Presbytery of Central Carolinas.

The motion was seconded followed by discussion from the floor. The motion was unanimously approved by voice vote.

- 03-21. The Chaplain of the Presbytery of Central Carolinas, TE Nate Wolcott, was invited by the Moderator to give a report. TE Nate Wolcott informed the court of the opportunity for members to gather in prayer each week on Tuesday morning at 10:00AM by Zoom. The weight of ministry and the challenges our congregations are facing deserve commitment to earnest prayer. The Court was encouraged to take advantage of these and other opportunities.
- 03-22. The Moderator recognized TE Eric Bartel who brought a report and recommendations from the Ministerial Committee. The report was in two parts with a presentation of candidates for ministry

and one ordained EPC Teaching Elders wishing to transfer into the Presbytery of Central Carolinas and an omnibus motion.

TE Eric Bartel introduced recommended Katie Piquette of House of Mercy and Chandler Owens of Warehouse 242 who desire to be received as Candidates for Ministry of the PCC. (G.11-2.B.) Both Candidates were examined as to Christian experience and growth, the motive for seeking ordination, and their testimony as to the call to the Ministry.

The Moderator presented the motion from the Ministerial Committee that Katie Piquette and Chandler Owens be approved as Candidates for Ministry in the Presbytery of Central Carolinas. The motion was approved by voice vote. TE Eric Bartel was invited to propound the following questions to the candidates, and they answered in the affirmative. (G.11-2.C.)

#### **Overture on Presbytery Boundaries**

From: Presbytery of the Central Carolinas
Presbytery of the Southeast
Presbytery of the New River

We rejoice and give thanks to God for the growth of the Evangelical Presbyterian Church, specifically in the area of the former Presbytery of Mid-Atlantic, which has been realigned into three presbyteries: the Presbytery of the Central Carolinas, the Presbytery of the Coastal Mid-Atlantic, and the Presbytery of the New River.

Twol churches in Western North Carolina which closely identify geographically and missionally with the Presbytery of Central Carolinas are located just within the boundaries of the Presbytery of the Southeast.

Plumtree Presbyterian Church, Plumtree, North Carolina Buck Hill Presbyterian Church, Newland, North Carolina

In accordance with the provisions of **Acts of Assembly 12-05** it has been determined by the Presbytery of the Southeast that the inclusion of those two churches in the Presbytery of Central Carolinas would not cause an adverse effect on total membership, financial resources, or any other measure enumerated in that act. The inclusion of those churches into the boundaries of the Presbytery of Central Carolinas would benefit the cost and mode of travel in both presbyteries.

Further, when mapping the congregations of the Presbytery of the New River within Western North Carolina, it was discovered that one of them is actually located just below the original southern boundary of that presbytery and is in the northern area of the Presbytery of the Central Carolinas. The two presbyteries agree that this church is actually a member of the Presbytery of the New River.

Adjusting the boundary between the presbyteries of Southeast and Central Carolinas along with correcting the boundary between Central Carolinas and New River would clarify the ministry area of these three presbyteries.

Therefore, the Presbytery of Central Carolinas, the Presbytery of the Southeast, and the Presbytery of The New River overture the 44<sup>th</sup> General Assembly to realign the boundaries of the Presbyteries of the Southeast, Central Carolinas, and New River within the state of North Carolina as follows:

Within the state of North Carolina, the eastern boundary of Southeast Presbytery will run along the eastern boundary of Haywood County and the western boundary of Transylvania County.

The Northern boundary of Central Carolinas Presbytery will run from the North Carolina-Tennessee border along the eastern boundary of Avery County, the western Boundary of Caldwell County, until it joins US 321 South to I-40 East. It will continue east on I-40 through Iredell County to the SW corner of Davie County. It will then follow the western boundary of Davie County and part of the western boundary of Davidson County to where it intersects I-85 North. It will continue along I-85 North to where it intersects the northern boundary of Randolph County. From there it will follow the northern boundaries of Randolph, Chatham, and Wake Counties to the western Boundary of Coastal Mid-Atlantic Presbytery.
